

Request for Tolling Personal Information

For Law Enforcement Purposes & Statutory Investigative Functions

USER NOTES

APPLICANT ELIGIBILITY

This application Form may be used by **government agencies with law enforcement or statutory investigative functions** (see below for additional limitations on which agencies can apply for tolling camera photos or data). Other applicants are required to serve a subpoena or lodge a <u>GIPA Act Access Application</u>.

INFORMATION WE CAN PROVIDE

Non-Trip Account Information

We can provide you with the name and address of toll account holders, and the credit card and vehicles that have been nominated on an account. To identify the correct account you must provide either an account number or customer name and address or you can provide a vehicle registration number.

Trip Information Captured By Our e-Tags

We can provide you with trip details captured by a TfNSW e-Tag. To identify the correct account you must provide either an account number or customer name (together with an address) or you can provide a vehicle registration number.

Trip Information and/or Images Captured by Tolling Cameras

Special rules apply to information and/or images captured by Tolling Cameras under <u>s.250A</u> Roads Act 1993 and <u>clause 25</u> Roads Regulation 2018.

- 1. If the toll was paid when the trip was made then information and images can only be released under a subpoena, warrant or NSW or Commonwealth statutory demand notice.
- 2. If the toll was not paid when the trip was made we can release information and images:
 - under a subpoena, warrant or NSW or Commonwealth statutory demand notice OR
 - to the following (using this Form):
 - ✓ ICAC (NSW) (see s.250A Roads Act 1993);
 - ✓ Australian Crime Commission (see s.250A Roads Act 1993);
 - ✓ Police (any jurisdiction) (see clause 25(b) Roads Regulation 2018); or
 - ✓ any NSW Public Sector Agency as defined in <u>s.3</u> Privacy & Personal Information Protection Act 1998 (see clause 25(c) Roads Regulation 2018).

CCTV & Security Cameras

For images collected by non-toll cameras use Form 5467.

TOLLING FRAMEWORK

Transport for NSW operates 2 toll roads: Sydney Harbour Bridge and Sydney Harbour Tunnel. Other toll roads are privately operated. Tolls may be collected via e-Tags or the use of tolling cameras combined with number plate recognition technology. Privacy rules (hence disclosure rules) vary depending on whether the information was collected by an e-Tag scanner or a tolling camera and whether or not the toll was paid at the time of the trip. Transport for NSW is the provider of e-Tags under the "E-Toll" brand. Other e-Tags are provided by the private toll service provider Tollaust Pty Ltd.
