

Apprentice Registration Rebate Claim

Use this form to claim a rebate on the cost of your vehicle registration if you are a first or second year apprentice registered with the NSW Department of Education and Training. Traineeships are not eligible for the rebate. The vehicle for which a rebate is claimed must:

- be registered in NSW
- be registered in the name of an eligible apprentice, or jointly with an eligible apprentice
- be registered for general private or business general use
- have been registered in the name of the apprentice, or jointly with an existing apprentice, at the time the registration fee and motor vehicle tax were last paid
- only have one rebate claimed in a financial year.
