

## Information sheet and Application form for Authorised Use of T-Way Lanes

(under NSW Road Rule 157-1) T-WAY

#### Important information

- Buses have absolute priority on the T-Way corridor.
- Under Road Rule 157-1 of the NSW Road Rules 2014, a driver (except the driver of an authorised T-Way vehicle) must not drive or stop in a T-Way Lane.
- Only Transport for NSW can provide authorisation to use the T-Way Lanes.
- Both Transport for NSW and NSW Police monitor the T-Way Lanes and enforce the road rule. The maximum penalty for breaking this road rule is 20 penalty units.
- This application does not authorise vehicles to use Bus and/ or Bus Only lanes.

### Eligibility and applying for authorised use of T-Way lanes

Authorised access to the T-Ways is by vehicle plate registration number. To be eligible for access to the T-Ways there must be reasonable justification as to why a vehicle requires access.

To find out if a reasonable justification exists, the registered operator of a vehicle must submit a written application to Transport for NSW outlining details of the access required and a reason for the request.

The application is then considered with reference to set assessment criteria. If approved, Transport for NSW will inform the registered operator and will provide two T-Way labels for attachment to the authorised vehicle.

#### Proof of required use

The Applicant must provide evidence in support of an application for required access. This could be documentation detailing the nature, scope and duration of a contract to carry out works on the T-Way, copy of the contract and/or subcontract and the type of vehicles needed for the work, for example.

If no such documentation is provided, the application for access may be denied or delayed.

#### Conditions of use

Authorised use of the T-Ways is subject to the following conditions. Penalties may apply for failing to adhere to these conditions.

- T-Way authorisation is not to be used for journey to work trips.
- Authorised access is for the vehicle, duration and purpose as set out in the letter of approval only.
- Authorised vehicles must display the T-Way labels.
- The labels should not be transferred to another vehicle.
- The labels should be removed and returned to Transport for NSW when access is rejected/cancelled or is no longer required.
- The labels must not be reproduced, copied, defaced or otherwise altered.
- Authorised access is subject to any other conditions that may be imposed by Transport for NSW.
- Peak bus operating times are 7am to 9am and 3pm to 6pm.
   Where possible routine inspections should not be undertaken during these times as vehicles using the T-Way interrupt the bus priority at traffic signals along the T-Way.
- Vehicles servicing the dedicated T-Way Lanes should access the T-Way via the nearest set of traffic signals to the area to be serviced.

#### **Invalid T-way labels**

The only valid authorised T-Way label is a black "T-Way" and logo depicted on a yellow background. All other labels are invalid and should not be displayed on any vehicle.

#### Displaying your labels

If authorised use of the T-Ways is granted by Transport for NSW, two labels will be provided with the letter of approval.

The labels are magnetic and should be placed in accordance with the legislation. That is, displayed in a prominent position on the vehicle adjacent to each number plate.

The T-Way labels supplied remain the property of Transport for NSW and are to be returned when no longer required.

Labels are not transferable between vehicles and Transport for NSW may revoke an authorisation prior to the expiry date nominated.

#### Changes to circumstances

If circumstances change and authorised access is no longer required, or the original justification for being granted authorised access no longer exists, you should advise Transport for NSW and return the labels to:
