

Application to Personalise an Existing Vessel Registration - Maritime Customers Only

- Personalised vessel registration can be a combination of alpha / numeric characters to a maximum of 6 followed by the letter 'N' eg: FISHN, ANCHORN, ABC123N
- If Transport for NSW considers the registration number to be offensive it will not be allowed.
- Applications must be accompanied by the current Certificate of Registration, proof of identity (*certified copies are acceptable*) and prescribed fee (cheque or money order if mailing application).
