

Alcohol Interlock Program Interlock Installation Certificate

Instructions to applicant

You may commence these steps within the 28 days before you are eligible to or intend to apply for an interlock licence.

STEP 1 Arrange an appointment with an accredited interlock service provider to have an approved interlock device installed in your vehicle. For a list of accredited interlock service providers, visit our website or contact us on **13 22 13**.

STEP 2 Complete Section 1 (Applicant's declaration) below. You must sign Section 1.

STEP 3 You must take this form with you to the accredited interlock service provider along with the letter titled 'Advice of eligibility for alcohol interlock program' that you received from Transport for NSW.

If you are applying for a fee concession, ensure you take evidence of your entitlement for the concession to the accredited interlock service provider. Information on eligible concession cards is available in the 'Alcohol Interlock Program Participant Guide'.

The accredited interlock service provider must complete and sign Section 2 (Accredited interlock service provider certification) and Section 3 (Accredited interlock service provider's declaration) below.

STEP 4 You must take the completed certificate to a Service NSW centre to apply for an interlock driver licence.

All sections of this certificate must be completed and is only valid for 28 days from the date of the installers signature in Section 3.
